

## **EDUCATION DATA TEAM SUPPORT (PRIMARY)**

### **Core provision (free of charge):**

*An executive school education profile (page 1) will be provided to all mainstream primary schools twice yearly*

*Support with all statutory data collections - end of EYFS, Y1/Y2 phonics check and end of KS2 teacher assessments*

#### Perspective Lite

*Access to documents within Perspective Lite*

*Ability to upload/download documents*

### **Service Level Agreement (chargeable)**

#### Perspective Lite

Access to realtime reports, interrogate your school's latest data by choosing parameters for bespoke key stage reports

#### Collection and collation of pupil performance data and provision of analysis and reports including:

- Collection of non-statutory assessments i.e.
  - Nursery "on entry" and "end of year" data
  - Data on entry to Reception year
  - KS1 teacher assessments
- Production of individual pupil reports (in pdf format) for Phonics and end of KS2
- Production of school analysis reports for EYFS, Phonics, end of KS1, MTC and end of KS2
- Production of reports for inclusion in school prospectus for end of KS2 showing school and national results for latest year
- Production of attendance summary report
- Telephone helpline advice and support on all of the above

### Service Provider's Responsibilities and Performance Targets:

- Will provide assessment booklets for start of academic year
- Will ensure that the current quality of service is maintained
- Will ensure that schools receive a timely response to requests for support

### School's Responsibilities if it decides to buy the package:

- The school must ensure that **complete and accurate data is available in line with the deadlines set by the Local Authority**

### School's Responsibilities if it decides not to buy the package:

- There will be no access to any of the above except for the statutory data collection exercises and executive School Education Profile (page 1)
- Schools will still be required to submit to the LA the statutory data in line with deadlines set by the Local Authority and **ensure that the data is complete and accurate**

### Costs

The Education Data Package is available at an annual lump sum charge per school plus an additional amount based on pupil numbers.
